Subject to conditions prescribed by the University of California, Los Angeles, sealed bids for a lump sum contract are invited for the following work:

MP200 B165-78 PET MRI INSTALLATION

**DESCRIPTION OF WORK:** Replacement of an existing High Intensity Focused Ultrasound (HIFU) MRI with a new Positron Emission Tomography (PET) MRI. Work shall include the provision of an MRI room with related control and equipment rooms, up-take rooms, a hot lab, an office, patient waiting area, dressing rooms, restrooms, and related support. The work includes the preparation for the installation of the new PET MRI equipment. PET MRI Equipment will be procured and installed by others.

Specific work includes the demolition of improvements in the way of work; removal and replacement of a portion of the concrete floor slab to accommodate the new equipment; provision of partitions; ceilings, lighting, fixtures, finishes, and casework; provision of nurse call and security systems; modifications to the existing fire alarm and fire sprinkler systems; provision of conduits and cabling for telephone and data; replacement of plumbing and utility piping; provision of power; replacement of air distribution and return ducts; provision of medical gas utilities ( oxygen, vacuum, air, nitrogen, nitrous oxide, and anesthetic); and repairs to building finishes impacted by the work. Additional work includes the provision of a new chiller in the adjacent parking garage, and related system controls.

All work shall be performed during non-business hours. Contractor shall coordinate and work with University vendor for the installation of PET MRI Equipment.

The estimated construction cost is \$2,858,495.00.

Bidder's completed Prequalification Questionnaire must be received at the above-listed University Contracts Administration office in a sealed envelope, or uploaded to the UCLA Online Planroom website, no later than:

Every effort will be made to ensure that all persons have equal access to contracts and other business opportunities with the University within the limits imposed by law or University policy. Each Bidder may be required to show evidence of its equal employment opportunity policy. The successful Bidder and its subcontractors will be required to follow the nondiscrimination requirements set forth in the Bidding Documents and to pay prevailing wage at the location of the work.

The work described in the contract is a public work subject to section 1771 of the California Labor Code.

No contractor or subcontractor, regardless of tier, may be listed on a Bid for, or engage in the performance of, any portion of this project, unless registered with the Department of Industrial Relations pursuant to Labor Code section 1725.5 and 1771.1.

This project is subject to compliance monitoring and enforcement by the Department of Industrial Relations.

The successful Bidder shall pay all persons providing construction services and/or any labor on site, including any University location, no less than the UC Fair Wage (defined as \$13 per hour as of 10/1/15, \$14 per hour as of 10/1/16, and \$15 per hour as of 10/1/17) and shall comply with all applicable federal, state and local working condition requirements.
