**DESCRIPTION OF WORK:** The Theatrical Department requires replacement of the existing Macgowan Hall Freud Theatre rigging and hoist system. Work shall include the demolition of the existing cable system and replacement with a new rigging and control system. Work also includes installation of new safety barriers on the grid level.

The estimated construction cost is \$650,000.
