Subject to conditions prescribed by the University of California, Los Angeles, sealed bids for a lump sum contract are invited from prequalified Contractors for the following work:

EPICURIA DISH ROOM EQUIPMENT REPLACEMENT
Project Number HH018 / CP1390

DESCRIPTION OF WORK: Contractor shall remove and replace existing food service equipment: flight type dishwasher; pulper system waste handling equipment; tray conveyers; and the associated mechanical, electrical, plumbing work to facilitate the new equipment installation. The scope of work also includes removal and replacement of existing flooring, ceiling and lights. Additionally, the work includes the installation of a new eye wash station.

The work will be divided into two phases: Phase 0 (preparation of submittals, receipt of University's approval, and procurement of applicable equipment) and Phase 1 (all remaining Work of the project including actual on-site construction Work).

The University currently anticipates that the on-site construction period (Phase 1) to begin no sooner than June 19, 2023 and to be completed no later than August 31, 2023. The work will be performed when Covell Commons Epicuria Dish Room is unoccupied, during Summer 2023.

Mandatory Pre-Bid Conference via ZOOM: The mandatory Pre-Bid Conference will be conducted via ZOOM and shall begin promptly at 10:00 a.m. Participants must log onto the ZOOM meeting at or before 10:00 a.m. (See ZOOM meeting instruction below.) Persons logging in later than said time will not be allowed to bid on the Project as prime contractors.

It is currently anticipated that the Conference/Job Walk will last at least 2 hours.)

LICENSE REQUIREMENTS: The successful Bidder will be required to have the following California current and active contractor's license at the time of submission of the Bid:

PREQUALIFICATION: University has prequalified general contractor bidders for this Project and posted a list of said firms on the UCLA Online Planroom website.

Every effort will be made to ensure that all persons have equal access to contracts and other business opportunities with the University within the limits imposed by law or University policy. Each Bidder may be required to show evidence of its equal employment opportunity policy. The successful Bidder and its

subcontractors will be required to follow the nondiscrimination requirements set forth in the Bidding Documents and to pay prevailing wage at the location of the work.

The work described in the contract is a public work subject to section 1771 of the California Labor Code.

No contractor or subcontractor, regardless of tier, may be listed on a Bid for, or engage in the performance of, any portion of this project, unless registered with the Department of Industrial Relations pursuant to Labor Code section 1725.5 and 1771.1.

This project is subject to compliance monitoring and enforcement by the Department of Industrial Relations.

The successful Bidder shall pay all persons providing construction services and/or any labor on site, including any University location, no less than the UC Fair Wage (defined as \$15 per hour) and shall comply with all applicable federal, state and local working condition requirements.
