GENERAL DESCRIPTION OF WORK: Provision of new cold fluid applied waterproofing membrane of the UCLA Cogeneration Plant chilled water concrete basin associated with the three cooling towers servicing the east most downcomer known as "Downcomer #3". The basin is located at the roof of the Facilities Management Building on the UCLA Campus. Details and descriptions of the scope of work is detailed in the permitted specifications and drawings.
