
We have completed reviewing the responses to our comments provided by Nabih Youssef & Associates (NYA), Structural Engineers. Our review was based on the submitted written responses, structural calculations and updated structural drawings, dated March 13, 2012.

This letter is to confirm that all outstanding peer review items have been resolved and we consider the seismic peer review completed. For this seismic upgrade, NYA elected to use Chapter 34 of the 2010 *California Building Code*, which references ASCE 41-06, *Seismic Rehabilitation of Existing Buildings*. As a matter of University of California policy, compliance with 2010 CBC Chapter 34 performance Criteria Levels 1 and 2, for buildings Occupancy Category I-III, satisfies the Seismic Performance Rating Level III, as defined by the University of California Seismic Safety policy, dated August 25, 2011.
