GENERAL DESCRIPTION OF WORK: The Department of Chemistry and Biochemistry proposes to renovate Laboratory Rooms 5073, 5076, 5077, 5085, 5086, 5090, and 5096, totaling 4,672 gsf (3,800 asf), on the fifth floor of the east wing of Young Hall, to create newly renovated lab space.

The proposed scope of work includes the installation of 21 new fume hoods; new flooring, wall finishes, research lab benches, chemical storage units, solvent purification systems, lab casework, furniture, and equipment; modifications to the building's mechanical, electrical, and life-safety systems to support the program, including new mechanical fan coil units, ductwork, and modifications to the lighting and controls, fire sprinkler, and fire alarm systems.
