

ADVERTISEMENT FOR PREQUALIFICATION
(Prime Contractor)
Re-Solicitation

Subject to conditions prescribed by the University of California, Los Angeles, responses to the University's prequalification documents for a CM at Risk contract are sought from prospective prime contractor bidders (hereafter "bidders") for the following project:

Los Angeles Tennis Center Seismic Remediation

PREQUALIFICATION OF PROSPECTIVE BIDDERS: The University has determined that bidders who submit bids on this project must be prequalified.

Prequalified bidders will be required to have both of the following California contractor's licenses:

B License (General Building) and A License (General Engineering)

GENERAL DESCRIPTION OF WORK: The project will improve the Los Angeles Tennis Center (LATC) from a Seismic Performance Rating of VI to a Rating of IV to comply with the University of California Seismic Safety Policy. Code-compliance improvements triggered by the seismic work, as well as additional venue-deficiency improvements included in the project, are further described below.

Seismic improvements include:

- Adding grade beams with battered micropiles at strategic locations throughout the stadium.
- Adding one additional grade beam without micropiles to the foundation near the first-floor offices.
- Adding fiber-reinforced polymer (FRP) strengthening to the top of the concourse slab at the northwest and southwest corners of the grandstand seating.
- Adding strips of FRP along the horizontal and vertical edge joints of the precast concrete seating tiers.
- Replacing eroded soil under the west grandstands with concrete slurry to cover the caissons and ensure the integrity of the foundation.

Accessibility and code-compliance improvements include:

- Accessibility upgrades to the west restrooms.
- Removing existing aluminum benches for seismic work, replacing them with new benches, and widening stepped access aisles.
- Adding accessible seating areas at the concourse level.
- Adding and replacing drinking fountains.
- Adding and modifying handrails and guardrails at stepped seating aisles.
- Replacing the fire sprinkler backflow preventer and installing any missing signage required for the existing Fire Department Connection.

Additional venue-deficiency improvements include:

- Repairing waterproofing and replacing the second-floor terrace surface above the first-floor offices.
- Adding waterproofing to the west exterior wall of the first-floor offices.
- Replacing Level 1 trench drains with a larger-capacity system to mitigate flooding during heavy rains.

Estimated Construction Cost: \$9,296,000.

MANDATORY PREQUALIFICATION CONFERENCE: A Mandatory Prequalification Conference will be conducted via ZOOM on March 25, 2026 beginning promptly at 10:00 a.m. Only bidders who participate in the Conference in its entirety will be allowed to submit prequalification documents and, if prequalification is achieved, bid on the Project as prime contractors. Participants must arrive at or before the above-specified time. Persons arriving later than said time will not be allowed to submit prequalification documents or submit bids as prime contractors. ***NOTE:** Attendee shall be a staff member of the prime contractor bidder's firm who will be actively involved in responding to this Prequalification, and who is highly knowledgeable of the firm's potential response to the prequalification criteria.*

SUBMITTAL DEADLINE: Each Bidder's completed Prequalification Questionnaire and associated documents must be received at the above-listed University Contracts Administration office in a sealed envelope, or uploaded to the UCLA Planroom website, no later than:

3:00 p.m., April 2, 2026

NOTE: Bidders who successfully prequalified during the first prequalification for this project remain prequalified and are not required to submit any further documentation or attend the mandatory Pre-Bid Conference. Refer to the UCLA Online Planroom website for a list of said prequalified entities.

NOTE: Only hard copy submittals or submittals uploaded to the UCLA Planroom website will be accepted. Oral, telephonic, electronic mail (e-mail), facsimile, or telegraphic Prequalification Questionnaires are invalid and will not be accepted. Only University's Prequalification Questionnaire (and associated documents) will be accepted. University reserves the right (but is not obligated) to request, receive, and evaluate supplemental information after the above time and date at its sole determination.

Any person or entity not satisfied with the outcome of the prequalification must file a writ challenging the outcome within 10 calendar days from the date of the University's written notice regarding prequalification determination. Any assertion that the outcome of the prequalification process was improper will not be a ground for a bid protest.

The dates, times, and location set for receiving and opening of bids will be set forth in an Advertisement for Bids.

The University reserves the right to reject any or all responses to Prequalification Questionnaires and to waive non-material irregularities in any response received.

All information submitted for prequalification evaluation will be considered official information acquired in confidence, and the University will maintain its confidentiality to the extent permitted by law.

Every effort will be made to ensure that all persons have equal access to contracts and other business opportunities with the University within the limits imposed by law or University policy. Each Bidder may be required to show evidence of its equal employment opportunity policy. The successful Bidder and its subcontractors will be required to follow the nondiscrimination requirements set forth in the Bidding Documents and to pay prevailing wage at the location of the work.

In addition, the University is committed to promoting and increasing participation of small business enterprises (SBEs) and disabled veteran business enterprises (DVBES) relating to all goods and services covered under the awarded agreement, subject to any and all applicable obligations under state and federal law, and University policies. The awarded contractor shall make best efforts to provide qualified SBEs and DVBES with the maximum opportunity to participate. The work described in the contract is a public work subject to section 1771 of the California Labor Code.

No contractor or subcontractor, regardless of tier, may be listed on a Bid for, or engage in the performance of, any portion of this project, unless registered with the Department of Industrial Relations pursuant to Labor Code section 1725.5 and 1771.1.

This project is subject to compliance monitoring and enforcement by the Department of Industrial Relations.

The successful Prequalified Bidder shall pay all persons providing construction services and/or any labor on site, including any University location, no less than the UC Fair Wage (defined as \$15 per hour) and shall comply with all applicable federal, state and local working condition requirements.
